# TEMPORARY VISIT FOR CHINESE CITIZENS (MULTIPLE ENTRY)



## Only for Residents of DC, MD, and VA

**[Definition]** Chinese citizens traveling to Japan for tourism, business affairs, commerce, conferences, visiting relatives/acquaintances as temporary visitor. It is not permitted to perform activities to undertake revenue generating business operation or activities to receive remuneration.

[Term of Stay] Stay of up to 30 or 90 days

[Validity of Visa] Multiple-entry: 3 or 5 years from date of issue

%The applicant may be required to submit additional documents, if needed. There is no guarantee that the applicant can obtain a multiple entry visa.

## • STATEMENT WHY YOU WANT TO APPLY FOR A MULTIPLE ENTRY VISA:

Please explain 1) Detailed purpose of visit to Japan, 2) Why you need or want to apply for a multiple entry visa, AND 3) Future planned trips to Japan.

## • BANK STATEMENTS FOR THE PAST 6 MONTHS:

Bank statement must be issued by a bank in the U.S. under your name and current address. If you have multiple bank accounts and/or investment accounts, you may submit all of them.

- Please fill out the **Multiple Entry Visa Funds Cover Page** spreadsheet that shows the month, account/bank name, and amount for each account/fund you are submitting.
- If the Principle Applicant is your parent(s), spouse, or child who qualifies for a multiple entry visa, but you do not, you can apply for a multiple entry visa as a Dependent. If so, 1) Please submit an application at the same time as the Principle Applicant together with proof of the relationship (i.e. marriage certificate, birth certificate) or 2) If the Principle Applicant already has a multiple entry visa, bring a copy of the Principle Applicant's Passport Bio Page, Valid Japanese Multiple Entry Visa, Proof of relationship, and your bank statement.

To complete the assessment in a timely manner, we ask that you submit the Visa Multiple Entry Funds Cover Page with the balance for each month, for each statement, and calculate the total for each month. If you are adding an account with foreign currency, please convert it into **US Dollars**. If it is not converted, we will not consider the account as a valid account.
